### **OFFICIAL MEMORANDUM**

Sub: Publication of Revised Provisional Seniority Lists  
of various cadres of K.S.A.T. – Reg.

The Hon'ble Supreme Court in its judgment cited under reference (1) above has declared that Sections 3 and 4 of the "Karnataka Determination of Seniority of the Government Servants promoted on the basis of Reservation (to the posts in the Civil Services of the State) Act, 2002", which provides for consequential seniority to those promoted under reservation against roster point to be *ultra vires* Articles 14 and 16 of the Constitution of India.

Pursuant to the decision of the Hon'ble Apex Court dated: 09-02-2017, the Government of Karnataka by its order dated: 06-05-2017 cited under reference (2) above, has directed that the seniority lists of all cadres in which promotions have been made in accordance with the existing policy of reservation in promotion and the seniority lists of all cadres higher than such cadres shall be reviewed and action shall be taken.

Accordingly, based on the judgment of the Hon'ble Apex Court and the guidelines contained in the Government Order cited under reference (2) above, Revised provisional seniority lists in which promotions have been made in accordance with the existing policy of reservation in promotion and the revised provisional seniority lists of various cadres are reviewed and published as under:
